\***Public Testimony:** The Commission encourages public comment on any agenda item. However, public testimony may be limited on items marked with an asterisk (\*). The asterisk means that the item has already been the subject of a formal public hearing or contested case hearing. On certain items marked with an asterisk, the Commission may be authorized to allow public comments. People wishing to speak to the Commission are asked to fill out a comment request sheet (available at the information table). Comments relating to a specific agenda item will be heard by the Commission as each agenda item is considered. Comments on other topics may be made during the public comment period on Friday at approximately 11:30 am.

Every attempt will be made to share with the Commission written comments that are delivered to the Director's Office in advance of the meeting date. Early delivery of written comments is strongly encouraged so that Commissioners have sufficient opportunity to review materials prior to the meeting. #### **DIRECTIONS TO THE MEETING**

**From I-5** – take exit 253; head east onto OR-22 towards Detroit Lake/Bend; go 83 miles, at Santiam Junction, continue onto US 20E for another 26 miles; continue through Sisters; take left onto Hwy 126 towards Redmond for 19 miles; turn left onto Hwy 97N; go ½ mile, take slight right on E Antler. Go ¼ mile and location is on your left.

**From I-84** – take exit 87 towards Dufur/Bend; head south on US-30/US-197/Dalles California Hwy for 38 miles; as you enter Maupin, stay on US197 S for another 22 miles; follow US 197S for another 25 miles to Shaniko Junction, it will turn into US 97S; Continue south on US 97 for 27 miles; turn left onto SE Evergreen Avenue/OR-126; go 1/8 mile to SE Franklin Avenue, turn left; go ¼ mile, turn right onto E Antler. Location is on your left.
