 - Request a funding decision from the Commission





Foundation for Funding Awards



- Each category is of equal importance
- 6 sub-level questions (public benefits) in each category





TRT evaluates if a project is likely to achieve Public Benefits:

- Considers current project only
- Evaluates likely change in conditions from project
- Considers positive and negative impacts
- Reviews evidence & documentation provided in:
 - Application
 - Letters of support or opposition
- Consults with others in own agency
- Debates with TRT members

Department engaged the City to request;

- 1. The Preliminary Assessment of the NEPA Evaluation and summary, and
- The option to expand descriptions of proposed tasks and anticipated public benefits.



- •The City of The Dalles provided the requested information
- •The project scope remains the same as described in the application
- Status and information was shared with the Confederated Tribes of the Warm Springs and WaterWatch of Oregon



Findings

- •The project details have not been expanded or altered
- •The additional information is not contrary to the information previously evaluated
- •The potential project outcomes are unchanged
- •The project details remain as evaluated by the TRT



Findings Continued...

•In original evaluation the TRT considered

- Fact that project does not legally protect streamflows through State
- Comments and topics of concern
- Presence & absence of documentation
- •TRT scored accordingly
- •With no change in project scope and outcomes, the score and funding recommendation do not change



Conclusion

The Department continues to recommend that the Commission accept the TRT funding recommendation and fund The Dalles' Dog River Project.



Funding Recommendation

The Commission may consider the following alternatives

1. Adopt the funding recommendation to fund The Dalles Municipal Watershed Dog River Pipeline Replacement Project for \$1,000,000.

2. Adopt a modified funding recommendation.

 Decline funding The Dalles Municipal Watershed Dog River Pipeline Replacement Project.

The Director recommends Alternative #1

1. Adopt the funding recommendation to fund The Dalles Municipal Watershed Dog River Pipeline Replacement Project for \$1,000,000.

2. Adopt a modified funding recommendation.
