### **DIRECTIONS TO THE MEETING**

### <u>From I-5</u>

Take Exit 256 (Market Street). Heading west on Market, go approximately 2 miles to Summer Street. Turn left onto Summer Street. Go less than 1/2 mile to the North Mall Office Building. The North Mall Office Building is located on your right between the Department of State Lands and the Employment Building.

#### **Parking**

Parking is located along Summer Street (Metered) and Winter Street (Metered and 90 minute parking).

There are six 2-hour parking stalls located between the North Mall Office Building and the Employment Building to the south. Parking is also available in the Yellow Lot which is located two blocks south of the building for a fee.
