

WRD Legislation

- •HB 2084 Extending the Sunset on Place-Based Planning
- •HB 2085 Modernizing Dam Safety Statutes
- •SB 51 Transfers of the Type of Stored Water

- •HB 5043 WRD Budget Bill
- •HB 5030 Bonding Bill



- Jurisdiction Non-federally regulated dams: water and wastewater
- Approval of modifications and receipt of final engineering documentation
- Fee for reviews of construction plans
- Guidance for owners on their responsibilities
- Process for safe removal of high and significant hazard dams



- Provide tools to address maintenance and safety issues, improving the safety of dams to protect people, property, and infrastructure
 - Cooperative plan and timeframe (particularly for seismic and floods), informal resolution, formal corrective action, injunction, civil penalty, and maintenance action
- Clarify WRD's general authorities and actions may take during a dam failure
- Operative date July 1, 2020

- Modification of Key Performance Measures
- POP 102: Funding of 6 positions and funds for Groundwater Studies
- POP 101: \$550,000 for place-based planning and continuation of the limited duration planning position
- POP 112: Authorizes ongoing position authority for payroll position



- HB 2856 funding for groundwater studies
- HB 2331 limits time to enforce well construction standards
- HB 2672 reimburse for cannabis enforcement expenses
- HB 3132 program for permitting restoration weirs
- HB 3182 onsite treatment of reclaimed water
- HB 2020 climate legislation
- HB 2377 funding for sediment study of lower Rogue River; reimbursement for increased pumping costs Umatilla



- HB 2536 development of staging areas for emergency response
- HB 2735 task force on Disaster Response and Recovery
- HB 2860 analyze groundwater contaminant data and provide grants to assist with addressing/education
- HB 3081 distributes money to Klamath County to install stream gauges in Klamath Basin
- HB 3326 algal blooms funding for OHA and DEQ



- SB 511 funding for Harney for ground water study and water conservation measures
- •SB 894 funding for Newport dams
- SB 946 transfers of stored water
- HCR 33 cooperative process to create a comprehensive state water vision



Other Legislation

- SCR 1 Supports development of closed-loop pump storage projects – Passed
- Various bills related to professional licensing
- Various proposals related to land use / housing
- HB 3430 removal of automatic stay on WRD orders – Died
- HB 3438 grandfather pond in Butte Creek watershed - Died
- MANY statewide bills
