2019 Session Legislative and Budget Update

I. Introduction

During this informational report, staff will provide a recap of the 2019 Session.

II. Background:

The 80th Oregon Legislative Assembly convened on January 22, 2019. The Legislature adjourned the 2019 Regular Session *Sine Die* on June 30, 2019. During session, more than 2,750 measures, not including amendments, were introduced and distributed among 12 Senate committees, 12 House committees, and 15 Joint committees. More information about the 2019 Legislative Session and the legislative process is available on the Oregon Legislature's website at www.oregonlegislature.com.

III. Session Outcomes: Budget Measures

A summary of the Department's budget is included in more detail in Attachment 1. All or a portion of the following Department Policy Option Packages were funded this session:

- Package 101 Placed Based Planning Community Support
- Package 102 Groundwater Data, Management and Protection
- Package 107 Investing in Projects to Meet Water Needs
- Package 112 Continuing Payroll Shared Services

In addition, the Water Resources Department received funds to distribute grants to: the City of Newport to design replacements for the Big Creek Dams (\$4 million), the Deschutes Basin Board of Control to pipe open-ditch irrigation canals (\$10 million), and to the Wallowa Lake Irrigation District to rehabilitate the Wallowa Lake Dam (\$14 million).

Aside from the Department's budget, other agencies that received funding of note included the Department of Administrative Services and the Higher Education Coordinating Commission. The Department of Administrative Services received funds for:

- Umatilla County to reimburse surface water pumping costs of ground water rights holders in critical ground water areas (\$1 million),
- Harney County School District #1J to drill a potable water well (\$175,000), and
- Klamath County to acquire, install and maintain stream gages in the Klamath Basin (\$30,000).

The Higher Education Coordinating Commission received funding for the Agricultural Experiment Station and the branch extension stations of Oregon State University (\$2.27 million) and Oregon State University Extension Service (\$410,000) for an integrated river basin water quality and quantity program.

Business Oregon, Department of Environmental Quality, Oregon Military Department, and other agencies also saw additional water-related investments not listed here pertaining to infrastructure, drinking water systems, and water quality, among others.

IV. Session Outcomes: Policy Measures

As discussed previously, the Department introduced three policy bills, two of which were enacted into law.

House Bill 2084 extends the sunset for the Department's Placed-Based Planning authority to July 1, 2023.

House Bill 2085, modernizes the state's dam safety program, which for the most part has not been updated in decades. The new law updates and adds new provisions related to dam construction and modifications, repair of unsafe and potentially unsafe dams, maintenance, emergencies, and removal. The law requires rulemaking; therefore, updates to Oregon Administrative Rules Chapter 690, Division 20, are expected to be before the Commission in 2020. Houe Bill 2085 becomes operative on July 1, 2020.

The Department's final measure relating to transfers in the type of water storage, Senate Bill 51, died on the first chamber posting deadline in the Senate Environment and Natural Resources Committee. Work to resolve this issue will continue in the interim.

No other water quantity related measures passed the legislature.

Four measures on professional licensing will require implementation by the Department's well driller licensing program. These measures include:

• House Bill 3030 and Senate Bill 688: Requires professional licensing boards to issue temporary authorization to a person who currently holds authorization to provide the regulated service in another state and who is married to a US Armed Forces member stationed in Oregon. Requires professional licensing boards to file annual reports about temporary authorization programming with the Legislature.

- Senate Bill 854: Requires professional licensing boards to accept federally-issued identification numbers (e.g. taxpayer identification number) on professional licensing applications in lieu of Social Security Numbers.
- Senate Bill 855: Requires professional licensing boards to study, develop, implement, and report to the Legislature about methods to reduce barriers to authorization for applicants who may be immigrants or refugees.

The Department tracked more than 700 measures, with less than 200 of those measures becoming law. A list of measures that passed the legislature that may be of interest to the Commission is included in Attachment 2.

V. Budget Note

One budget note was approved by the legislature, which directs the Department to compile information regarding actions it has taken that resulted in being party to a contested case hearing or legal action between 2015 and July 1, 2019. The report is due to the Joint Committee on Ways and Means on January 1, 2020. More information is provided in Attachment 1 and staff have begun work on the report.

VI. Water Committee and Legislative Days

Over the interim, the House and Senate committees will meet during Legislative Days scheduled for September 16-18, November 18-20 and January 13-15. The Speaker of the House recently appointed a House Water Committee, including the following members:

VII. Conclusion



HB 5043 - Budget / HB 5030 - Lottery Bonds / HB 5050 - Budget Reconciliation

Place-Based Planning Community Support: Provides \$550k general fund to support current place-based planning groups in Malheur Lake, Lower John Day, Mid-Coast, and Upper Grande Ronde, as well to conduct an evaluation of the place-based approach to water planning. Continues existing NRS 4 planning coordinator (\$230k). Modified Governor's Recommended Budget (GRB) Package #101. Integrated Water Resources Strategy (IWRS) Recommended Action: 9.A

Groundwater Basin Studies: Authorizes \$1.6m general fund, including 6 positions, to increase the state's understanding of water supplies by allowing the Department to conduct one additional groundwater study at a time, while also preparing other basins for study. The next basin intended for study is the Walla Walla Subbasin. Each basin study takes between five to six years to complete. Directs the Department to use \$300k in existing Other Funds limitation (Exempt Use Fees) for cost share expenses related to the studies. *Modified GRB Package #102. IWRS Recommended Actions: 1.A and 1.B*

Payroll Shared Services: Makes permanent an existing shared services payroll accounting technician (\$147k other fund) who is a member of the team that provides payroll and benefit services to over 500 staff in six different agencies. *GRB Package #112*.

Grants and Loans to Implement Water Projects:

Water Projects Grants and Loans – Provides Lottery Revenue Bonds funding, plus the cost of issuance, for grants and loans for water supply projects to meet instream and out-of-stream water needs (\$15M). GRB Package #107. IWRS Recommended Actions: 10.E, 10.A, 10.B, 10.C, 3.A, 11.B, and 13.E.

^{**}Other Funds (Grants and Loans) includes Lottery Revenue Bond proceeds in the amount of \$42 million in carry forward from the 2017-19 biennium and \$43 million in new bonding (plus the cost of issuance).

Grants and Loans to Implement Water Projects (continued):

- Deschutes Basin Provides Lottery Revenue Bond funding, plus the cost of issuance, to the Department in the Water Supply Development Account for the Deschutes Basin Board of Control to pipe open-ditch irrigation canals to conserve water and enhance fish and wildlife habitat (\$10M). IWRS Recommended Action 10.A.
- Dam Safety Allocates Lottery Revenue Bond funding, plus the cost of issuance, to the Department in the Water Supply Fund for Wallowa Lake Irrigation District to rehabilitate Wallowa Lake Dam (\$14M), and for the City of Newport for planning, environmental permitting, and design costs to replace the Big Creek Dams (\$4M). IWRS Recommended Action: 7.C.

Budget Note

Directs the Department to compile information regarding actions that the agency has taken that resulted in the agency being party to a contested case hearing or legal action since 2015. This includes past, current, and pending items as of July 1, 2019. For each case, the department must identify the legal question being addressed, the underlying statute(s) or administrative rule(s) that were, or are, the basis for the action that the agency undertook, and the fundamental basis or reasoning for the dispute against the agency's actions. If a statute or administrative rule is identified as being foundational to actions taken by the agency that are subject to multiple contested cases or other legal proceedings, the agency must provide a statement regarding the purpose for the statute or rule, what the agency is attempting to achieve by taking action on the statute or rule, and how future litigation regarding those actions might be avoided in the future. The agency is directed to report this information to the Joint Committee on Ways and Means in a format approved by the Legislative Fiscal Office by January 1, 2020.

Water Resources Department Legislation

<u>HB 2084</u> – Place-Based Integrated Water Resources Planning: Extends the sunset from July 1, 2019 to July 1, 2023 to allow the state to continue to pilot the place-based approach to water planning. *IWRS Recommended Action #9a*

<u>HB 2085</u> – Dam Safety Program: Clarifies the scope of the Dam Safety Program and Department authorities. Specifies processes for dam construction, modification, maintenance, and removal. Establishes fees for reviews of new dams or modifying the dam height. Provides tools to work with owners and to improve the safety of dams to protect people, property, and infrastructure when a high or significant hazard rated dam is deemed unsafe, potentially unsafe, or in need of maintenance. Includes enforcement provisions. Specifies owner responsibilities and Department authority in emergencies. Operative July 1, 2020. *IWRS Recommended Action #7c*

Select Other Legislation Requiring Department Action

Laws in this section are applicable to the Department's Well Constructor Licensing Program.

<u>HB 3030</u> and <u>SB 688</u> – Temporary Authorization: Directs professional licensing board to issue temporary authorization to persons holding eligible credentials from another state and that is married to a member of the U.S. Armed Forces serving in Oregon, and annually report to interim committee of Legislative Assembly.

<u>SB 854</u> – Acceptable Identification: Directs professional licensing boards, in certain circumstances, to accept individual taxpayer identification number or other federally-issued identification number in lieu of Social Security number on applications for issuance or renewal of authorization to practice occupation or profession.

<u>SB 855</u> – Professional Practice Authorization Study: Directs professional licensing boards to study manner in which persons who are immigrants or refugees become authorized to practice occupation or profession and reduce barriers to authorization. Requires boards to report to Legislative Assembly not later than November 30, 2019.
