Commissioner Kihara moved to Issue the Final Order included as Attachment 7, cancelling the portion of Water Right Certificate 2366 located within Tax Lots 300 and 302, and cancelling the portion of Water Right Certificate 22086 located within Tax Lot 302, directing the Department to issue certificates confirming the portions of Certificate 2366 and 22086 not cancelled, seconded by Vice-Chair Corn.
