This publication lists agency activities requiring public notice. It also describes public comment processes and deadlines. Types of water use requests in this week's Public Notice include:

* **Permit Application Initial Reviews, Proposed Final Orders, and Final Orders** Applications for permits to use, store, divert or pump surface water or groundwater. Includes applications by the state Departments of Fish & Wildlife, Environmental Quality or Parks and Recreation for water to be used and kept in-channel.

* Expedited Secondary Applications to Use Stored Water

Applications to use stored water exclusively, filed under a simplified review process.

* Applications for Allocation Of Conserved Water

Applications made by a water user who conserves water to use a portion of the conserved water on additional lands, lease or sell the water, or dedicate the water to instream use.

- * Applications for Extensions of Time to Perfect Water Right Permits New applications received and proposed final orders regarding requests to extend time limits to fully develop water use projects and beneficially apply water.
- * Extension of Time Checkpoint Progress Reports filed pursuant to OAR 690-315 Documents the progress made toward development of the water use project since approval of the last permit extension and/or the last progress report checkpoint. (OAR 690-315 pertains to permit extension applications filed on or after July 1, 2001.)
- * Applications for Limited Licenses Requests to use water for 5 years or less. Licenses are subordinate to other rights and may be revoked if a use is found to injure other water right holders.
- * Application for Instream Lease

Application by water right holder to lease existing water rights to instream use.

* Transfer Applications: Regular

Requests to change point of diversion or appropriation, place of use, or character of use upon which the public may comment. The changes may be proposed in an application for a transfer (including instream or historic POD), an exchange, or a substitution.

* Transfer Preliminary Determinations

Requests to change point of diversion or appropriation, place of use, and character of use upon which the public may protest the application and Department's preliminary determination.

* Transfer Applications: Temporary Transfers

Requests to temporarily change place of use and, if necessary to convey the water to the new place of use, to temporarily change the point of diversion or appropriation.

- * **Transfer Applications: Permit Amendments** Requests to amend permits.
- * **Transfer Notice: District Permanent Transfers for Place of Use- ORS 540.580(4)** District notices filed for place of use changes within a district's boundary.

* Certificate Issuance



Initial Review and Proposed Final Orders

The following pages of this notice list permit applications that the Department is evaluating for compliance with state water law. Public participation and comment is encouraged. Opportunities for public involvement vary according to the stage of the permit evaluation. Ground water permit applications in the Deschutes Basin (Basin 5) may seek to provide mitigation pursuant to the Deschutes Ground Water Mitigation Rules.

Initial Review Stage (IR)

The Department has given the applicant an initial review of water-use restrictions, water availability and other limitations that affect the agency's decision on whether to issue a permit. The Department welcomes comments from interested persons, agencies and organizations on the proposed water use. **The comment deadline for initial reviews appearing in this public notice is 5pm, Thursday, April 01, 2021.** Although we cannot respond individually to all comments, each will be considered as the agency makes its decision regarding proposed allocations.

Proposed Final Order Stage (PFO)

The proposed final order is the Department's penultimate decision on the water use request. The PFO documents the agency's decision through specific findings, including review of comments received. If appropriate, it includes a draft permit specifying any conditions or restrictions on the use. Persons interested in receiving a mailed copy of a PFO must pay a statutorily-required fee of \$30. (Any person paying \$30 to receive a PFO by mail will also receive a copy of the Final Order when it is issued.) PFO's may be viewed free of charge online at: <u>http://apps.wrd.state.or.us/apps/wr/wrinfo/</u>. Those disagreeing with the Department's decision as expressed in the PFO have 45 days to file a protest.

The protest deadline for proposed final orders appearing in this public notice is 5pm, Friday, April 16, 2021.

The protest filing fee is \$410 for the applicants and \$810 for non-applicants. Detailed requirements for filing a protest are included in the PFO. Persons who support the PFO may file a "standing" fee of \$230 to retain the ability to participate in future proceedings relating to an application. Before participation in a hearing is allowed, an additional \$580 will be required to request to participate as a party or limited party.

If a protest or comment deadline falls on a day that the office is closed, then the next open business day automatically becomes the deadline date.

Applications for Allocation Of Conserved Water

The following applications for allocation of conserved water have been received pursuant to ORS 537.455 to 537.500 and OAR Chapter 690, Division 18. In reviewing the applications, the Department will consider whether the diversion for the uses allowed under the original water right will be reduced by the conservation project, whether existing water rights will be protected from injury, and whether the project is in compliance with local comprehensive land use plans.

Notice of Amended Application for Allocation of Conserved Water CW-116

On April 2, 2020, Tumalo Irrigation District (TID), 64697 Cook Avenue, Bend, OR 97703, filed an application for Allocation of Conserved Water for Certificates (Certs.) 74146, 74147, and 74148 under ORS 537.470. On February 17, 2021, TID filed an amendment to the application to include additional piping projects. Certs. 74146, 74147, and 74148 were superseded by Certs. 95175, 95176, and 95177, respectively. Cert. 95175 is for a total of approx. 53.95 cubic feet per second (CFS) from Tumalo Creek, tributary of the Deschutes River for Irrigation of approx. 5801.5 acres, domestic use including livestock. Cert. 95176 is for 136.0 CFS from Tumalo Creek with any deficiency to be made up by diverting no more than 40.0 CFS from Crater Creek, 34.0 CFS from Little Crater Creek, and 1.0 CFS from Three Springs Branches for irrigation (and other uses) of 1579.7 acres-equivalent, and supplemental irrigation of 5010.9 acres. Cert. 95177 is for 32,268 acre-feet (AF) from Crescent Lake Reservoir for supplemental irrigation of approx. 7381.2 acres. The conservation project proposes to pipe open unlined laterals (Steele, Highline, 2 Rivers (Box S), Parkhurst, Gill, Lacy, and Allen) with HDPE pipe conserving the following quantities of water: Cert. 95175, approx. 1,204.2 AF / up to 3.299 cfs with priority dates of 8/5/1900, 9/1900, 4/28/1905, 5/27/1907, and 6/1/1907; Cert. 95176, approx. 979.9 AF / up to 6.154 cfs with a priority date of 10/29/1913; and Cert. 95177, approx. 1,936.9 AF with a priority date of 4/7/1911. TID proposes 100% of the conserved water to be protected instream. Any party may provide written comments directly related to CW-116 within 20 days of the last date of newspaper publication, 03/04/2021. Comments should be sent to ACW Program, Water Resources Department, 725 Summer Street NE, Suite A, Salem, OR 97301-1266. WRD will review all comments received when determining whether to approve the proposed ACW.

Applications for Limited Licenses

A limited license allows the right to use or store water for no more than 5 consecutive years. Use of water under a limited license is subordinate to all other authorized uses and may be shut-off at any time to satisfy those other uses. In addition, the Department may revoke a limited license if its use causes injury to any other water right or minimum perennial streamflow.

Licensees must maintain a record of how much water they are using (ORS 537.143). **The Department may approve a license after March 16, 2021, upon finding that the proposed water use will not impair or be detrimental to the public interest (OAR 690-340-030).** The public is invited to provide comments that will assist the Director in determining whether the use would impair or be detrimental to the public for a use that is not one of the standard uses listed in OAR 690-300, the Department may, for the purposes of this notice, assign a named use that is reasonably close to the use actually requested. The public may examine the actual application by clicking the associated hyperlink and then choosing "LL Application" under "Scanned Documents."

Applications for Instream Lease

The deadline for submitting claims of injury to existing water rights or enlargement of the original right against a lease application is March 23, 2021. Parties to the lease, including the Department, will review any such claims before the lease is finalized.
