Kim Fritz-Ogren, Water Resources Development Program Manager, and Becky Williams, Grant Program Coordinator, presented the funding recommendations for the 2020-21 funding cycle of Feasibility Study Grants.

Vice Chair Corn commended staff on the report, and noted he was pleased with the geographic diversity of the applicants and that small grants were able to be competitive in the process. Commissioner Baumgartner inquired about the Upper John Day ASR Study in terms of approval of their resubmittal. Commissioner Moll commented on the application scoring process. Commissioner Kihara moved to approve the funding recommendations for the 2020-21 funding cycle, seconded by Vice Chair Corn.
