Chair Reeves called the meeting to order and explained the process and purpose of the meeting. Chair Reeves noted this would be the last meeting with Commissioner Baumgartner and Vice Chair Corn, and invited attendees to say farewell after the meeting adjourns.

A. Commissioner Comments

Commissioners reported on their recent activities, shared information, and commented on a variety of water resource topics. Commissioner Moll commented on the extraordinary water year. Commissioner Quaempts commented on the need to measure and report variability when managing water. Commissioner Kihara talked about the depth and extent of the drought. Commissioner Smitherman noted the public is becoming more interested in water and the challenge that presents in terms of addressing concerns.

Commissioner Baumgartner noted the severity of drought conditions, and Vice Chair Corn noted seeing the benefits of past efforts to manage and conserve water. Chair Reeves pointed out the importance of working with the community on water challenges and gave an update on OWEB activities.

B. Approval of Minutes

The minutes of the June 3, 2021 meeting were presented for Commission approval. Vice Chair Corn moved to approve the minutes, seconded by Commissioner Kihara. Voting in favor of the motion: Baumgartner, Quaempts, Corn, Moll, Reeves, Smitherman, and Kihara. Motion passed.

C. Director's Report

Tom Byler, Director, provided an update on Department business and late-breaking issues. Director Byler noted the need to be mindful in terms of the Legislature's investment in water and thoughtful about building a foundation moving forward. Kudos to WRD staff for dealing with drought issues, especially in the Klamath Basin.

D. Critical Groundwater Area Three Year Review

Justin Iverson, Groundwater Section Manager, reviewed conditions in the Butter Creek and Stage Gulch Critical Groundwater Areas and the associated basin program rules in OAR 690-507-610 through 840, as per the review requirements of ORS 537.780(3). Vice Chair Corn asked about Butter Creek in terms of impacts to groundwater recharge rates and surface flow variability. Commissioner Quaempts stressed the need to better measure, monitor, and report the effects of water year variability and to develop effective and timely adaptive management responses to address those impacts on groundwater supplies. Commissioner Baumgartner discussed adaptive management and asked whether there are sufficient triggers in critical groundwater areas to determine if rules should be modified. Commissioner Moll inquired about the value of junior water rights in critical areas and the feasibility of using public funds to purchase rights from willing sellers, and Chair Reeves mentioned an interest in more information on surface water and groundwater interactions, and the value of junior water rights in critical areas.

E. Oregon Water Futures Project

Stacey Dalgaard, Oregon Environmental Council; Cheyenne Holliday, Verde NW; Lynny Brown, Willamette Partnership; and Taren Evans, Coalition of Communities of Color, discussed the work of the Oregon Water Futures Project, which was formed to elevate water priorities from Oregon Communities. Commissioner Smitherman noted the complexities of water priorities and Commissioner Moll commented on the need to reach out more broadly to communities around the state. Commissioner Quaempts commented on the need to provide positive examples of productive engagement, noting the Department's work with the CTUIR, and pointed out today's report was very different from OBC's report, but can still complement each other. Commissioner Baumgartner inquired about ways to overcome the distrust of the community. Director Byler thanked the panel for their presentation and noted the Department looks forward to working with them in the future.

F. Drought Update

Larry O'Neill, State Climatologist at Oregon State University; Racquel Rancier, Policy Manager; Rachel LovellFord, Surface Water Hydrology Program Manager; Ryan Andrews, Hydrologist; and Bryn Hudson, Water Policy Analyst, provided an update on current drought conditions, coordination and communication efforts, and support available for water users. Vice Chair Corn noted his appreciation of the monthly drought reports. Commissioner Moll mentioned the need to look at storage as a way to adapt to the changing climate. Commissioner Baumgartner noted the historical record may not be the best approach in terms of planning for the future. Commissioner Quaempts suggested climate change is transitioning rather than existing as the new normal, and variability is an important factor in planning.

Racquel Rancier, Policy Manager; Lisa Snyder, Administrative Services Division Administrator; and Bryn Hudson, Water Policy Analyst, provided an update on the 2021 Legislative Session and the 2021-2023 budget. Commissioner Quaempts commented on the increased budget in terms of the challenge to hire staff to implement the work that needs to be done. Vice Chair Corn commented on the need to hire qualified staff, and Commissioner Moll noted the need for the Department to track projects for the purpose of keeping the Commission informed of progress.
